Somanathan, Professor, Indian Statistical Institute.

Our social interactions are important, too, as we renew old friendships and meet new colleagues in our field and there are some wonderful events planned while we are here. In addition, we are looking forward to recognizing some of the top scholars in our associations with awards for AERE Fellow and EAERE Outstanding Achievement Awards Recognizing Excellence (European Lifetime Achievement Award in Environmental Economics, European Practitioner Achievement Award in Applying Environmental Economics, European Achievement Award for Researchers in Environmental Economics under the Age of Forty); for outstanding publications in ERE and JAERE; the AERE Publication of Enduring Quality Award, the EAERE Award for ERC Grants laureates in the field of environmental and resource economics, and the Best Poster Awards.

# Welcome message from Local Organizing Committee



#### Dearest friends and colleagues,

We want to welcome you very warmly to Gothenburg! This is the second time we organize a large conference on environmental economics and this is no coincidence: we love to see our colleagues from across the World. In 2008, we had a European conference here. This time it is twice as big and it is a World Congress. We are pleased to welcome you to one of the homes of environmental economics. We are a large research group that works in this area since many decades back and we are doing our best to make you feel at home and to make this conference a truly inclusive event. Some of the highlights such as plenaries have been mentioned by the Presidents. We have tried to make the programme as interesting as possible for all different strands of our disciplines and for researchers from all over the world. I would like to dwell a moment on the purpose of a conference. We have spent the last year and a half fundraising and organizing the congress. I have been to all the World- and European conferences in environmental economics and so I have had time to think about this. We care about the environment and we care about research. We want the plenary events to be thought-provoking conversation starters. We want a diversity of challenging topics and approaches. But we also want our research to have impact in the so called "Real World". In the first EAERE conference almost thirty years ago we were not much more than 50 people and now we are over 1500. New journals are started where we publish and new associations are started where we interact. We welcome in particular the new association CAERE from China that is newly formed but already making a strong presence with their own pre-conference here in Gothenburg.

Environmental economics has come a long way over these decades. When I welcomed many of you here ten years ago, EAERE turned 18 and we noted that environmental economics as a discipline had come out of its adolescence. At the 19th EAERE conference in Prague, V Kerry Smith in his keynote challenged our profession that the severity of climate change and other environmental challenges throughout our economies ought to bring environmental economics to the forefront of economic policy. I would like to claim that we are there now! It is impossible to conceive that the world would meet the SDGs and the commitments in Paris without serious application of environmental economics. This is particularly evident in the Global South where important decisions are taken now to forge a sustainable development for their countries.

To reflect the increasing traction of environmental economics in policy-making we have a much greater emphasis on practitioners and policy makers. At previous conferences there has been a tradition to have a keynote in honor of the late David Pearce. At this World Congress we have multiple events that are directed to practitioners and policy-making and not least focusing on the Global South. We have several pre-conferences and courses that are in particular directed to environmental economists who work at various EPAs and other similar institutions. We have around 30 policy sessions which means that there will in every time slot be several policy oriented sessions to choose from, in addition to the many other thematic and parallel sessions. Finally we also have two special policy plenary events. Today we face a double dilemma with serious environmental threats as well as serious threats to democracy and good governance. Gina McCarthy who was appointed by President Obama as the 13th Administrator of the USEPA has chosen as her topic the "assault on science and truth". This will be just at the end of the pre-conference for practioners and at the beginning of the main conference on Monday evening. On Tuesday evening there will be a debate on the predicament of our global

climate governance between representatives from the USA (Gina McCarthy), EU (Jos Delbeke), China (Professor Hua Wang) and India (Professor E Somanathan).

We have also been keen at this meeting to live as we preach. It is hard to avoid air travel in a global conference. In the EAERE 2008 we actually put a lot of effort into getting the European railways to sponsor and support the conference. That was not easy and experience shows that it has become even more difficult to travel to Sweden even from Germany or France by train. This is an area which needs much more work. We trust most people pay climate compensation for their air travel - even if many of us doubt that is enough! We are sometimes accused of being hypocrites who travel around to conferences discussing taxation of air travel to stop tourists going on vacation. We must reflect on this but we believe the scientific value of climate conferences for overall policy can be worth more than the tons of CO2 emitted. But this will only be the case if we make the most of our time together by getting to know new people, challenge and improve each other's ideas and strike up new research collaborations. So socializing is important during the coffee breaks and social events and we thank our sponsors who have contributed to them. Let us ensure that the carbon emitted for WCERE 2018 results in better research and greater policy impact. The purpose is to get that extra human touch and contact that you don't get by reading the articles online. It is Midsummer and this is the best time of the year to visit Scandinavia. With any luck the sun will shine, our plentiful and empty nature will be beautiful and welcoming. We hope that you make the best use of your trip here and extend it to see the wonders of our environment.

Another way in which the conference affects the environment is through the food we eat and waste we produce. Red meat is (largely because of methane) a rather overlooked but very important driver of climate change. We have decided to try to make the food a culinary experience and at the same time to be largely vegetarian. There will be a small amount of non-vegetarian options on one occasion – it is Midsummer and we are by the sea so there will be a little seafood but just as a supplement. The main focus will still be vegetarian. We will not be handing out a lot of "stuff" like programs, brochures, pens etc. This also means that we will not be handing out bags to put the stuff in. In our experience the transformation of all this "stuff" to waste is rapid - virtually instantaneous. We have however bought umbrellas. Although we remain eternal optimists and believe in summer weather forever, we also believe in prudence and insurance and hence umbrellas.

We hope that you will enjoy the social programme and

meet new people. We are very keen on making the World Congress INCLUSIVE. Being inclusive means that we listen to and make room for people with other ideologies, backgrounds, disciplines and cultures. We make an effort to reach out to related disciplines be they forestry or fishery specialists, ordinary economists, macro or micro, ecological economists, political scientists and other disciplines that are close to ours or environmental scientists from all disciplines. Being inclusive at a World Congress means making a special effort to reach out to other countries and regions, particularly those typically less represented at such meetings. We are proud and pleased that we have received large contributions from the Swedish International Development Cooperation Agency, the International Development Research Centre, the Agence Française de Développement, the Environment for Development Initiative, EAERE and others that have facilitated funds for a record number of scholarships for participants from low income countries.

When such a heterogeneous crowd is making friends and having a good time we need to remember that respect takes many forms and hope that many of us make the extra effort to understand people from different cultural backgrounds. We are still within the year in which #Metoo exploded and we should all have learnt something about the importance of meeting people with love, care and respect. I hope that at this conference we will show each other the maximum of respect in all dimensions – personal, political, cultural and intellectual! I also hope you will learn a lot, enjoy yourself and make many new friends.





# Plenary speakers



Nava Ashraf London School of Economics

Nava Ashraf is Professor of Economics at the London School of Economics and Political Science and Director of Research at the Marshall Institute for Philanthropy and Social Entrepreneurship. Professor Ashraf is affiliated to M.I.T. Jameel Poverty Action Lab (J-PAL), Centre for Economic Policy Research (CEPR) and Bureau for Research and Economics Analysis of Development (BREAD). She has a background at Harvard Business School.

Nava Ashraf conducts research at the intersection of psychology and economics, using both lab and field experiments to test insights from behavioural economics in the context of global development in Africa, Latin America, and Southeast Asia. Her research also covers questions of intra-household decision making in the areas of finance and fertility.



Meredith Fowlie University of California

Meredith Fowlie holds the Class of 1935 Endowed Chair in Energy at University of California, Berkeley, and is an Associate Professor in the Agriculture and Resource Economics department. She is a research associate at UC Berkeley's Energy Institute at Haas and the National Bureau of Economic Research.

Meredith Fowlie is an applied economist combining the fields of industrial organization, energy markets, and environmental economics. Much of her work investigates how market-based environmental regulation – emissions trading programs in particular – are working in practice. Dr. Fowlie is also interested in the demand-side of energy markets and work that integrates methods and models from other disciplined into economic analysis of policy outcomes. Her research has been published in The American Economic Review, The Journal of Political Economy, The Review of Economics and Statistics among others.



#### Lata Gangadharan Monash University

Lata Gangadharan is Professor of Economics and holds the Joe Isaac Chair in Business and Economics at Monash University. Her research focuses on understanding and designing appropriate institutions for the environment and for development. She is a Co-Editor of Experimental Economics and is a Fellow of the Academy of Social Sciences in Australia.

Lata is an experimental economist, and has conducted lab and field experiments to examine incentives in environmental markets, attitudes towards peer punishment to solve environmental dilemmas, propensity for corruption in different countries, and impact of gender, norms and social identity. Lata's research is published in journals such as the American Economic Review, Science, Nature Communications, European Economic Review, Journal of Public Economics, Journal of Environmental Economics and Management and American Journal of Agricultural Economics.



Sir David Hendry Oxford University

Sir David Hendry is Professor of Economics at University of Oxford and Director of Program in Economic Modeling, Institute for New Economic Thinking at the Oxford Martin School. Before coming to Oxford in 1982, he was a Professor at London School of Economics and University of California at San Diego. In his research, Professor Hendry investigates the theory and practice of econometric modelling and forecasting in a non-stationary and evolving world, where the model differs from the economy.

David F. Hendry received a Lifetime Achievement Award from the Economic and Social Research Council in 2014, and the Isaac Kerstenetzky Scholarly Achievement Award in 2012. He has been awarded eight Honorary Doctorates, and is one of the World's 200 most cited economists according to the ISI. He was knighted in 2009 for services to social sciences.

# Policy plenary speakers




Gina McCarthy Harvard University

McCarthy's 35-year career in public service has been dedicated to environmental protection and public health. As Administrator of the U.S. Environmental Protection Agency under President Barack Obama, she was the nation's leading advocate for common-sense strategies to protect public health and the environment, including efforts to address the challenge of climate change and ensure the protection of the country's water resources. Her leadership led to significant federal, state, and local actions on critical issues related to the environment, economic growth, energy, and transportation. Since leaving Washington, McCarthy has been a fellow at Harvard's Kennedy School of Government's Institute of Politics and the Menschel Senior Leadership Fellow at Harvard's T.H. Chan School of Public Health and joined Pegasus Capital Advisors, a private equity firm, as an operating advisor focused on sustainability and wellness investments. McCarthy now also serves as Professor of the Practice of Public Health in the Department of Environmental Health at Harvard's T.H. Chan School of Public Health and Director of Harvard Chan's Center for Climate, Health and the Global Environment, leading the development of the School's strategy in climate science, health, and sustainability.



Jos Delbeke EPSC - European Political Strategy Centre

Jos Delbeke (1954, Belgium) has been the Director-General of the European Commission's DG Climate Action since its creation in 2010. As of 16 March 2018, he was appointed Senior Adviser for Relations with the European University Institute, European Political Strategy Centre, European Commission. He joined the European Commission in 1986. He was very involved in setting the EU's climate and energy targets for 2020 and 2030, and the adoption of the related legislation by the EU Council and Parliament. Mr Delbeke has been a key player in developing EU legislation on cars and fuels, the Emissions Trading System (ETS), air quality, emissions from big industrial installations and chemicals (REACH). As an economist, he always underlined the role of market-based instruments and of cost-benefit analysis in the field of the environment. Mr Delbeke has been responsible for developing Europe's International Climate Change strategy and he was for many years the European Commission's chief negotiator at the UNFCCC Conference of the Parties. He holds a PhD in economics (Louvain, 1986) and worked in 1985 at the International Monetary Fund (Washington DC, USA). As of 2013 he is lecturing at the University of Louvain (Belgium) on European and international environmental policy".



E. Somanathan Indian Statistical Institute

E. "Som" Somanathan is Professor in the Economics and Planning Unit of the Indian Statistical Institute in Delhi, and Program Director of CECFEE (Centre for research on the Economics of Climate, Food, Energy and Environment). His research is in the economics of environment and development, microeconomic theory, and evolutionary models of behavior. He received his PhD from Harvard University and has taught at Emory University, the University of Michigan, and Princeton University. He has been Executive Director of SANDEE (South Asian Network for Development and Environmental Economics), a Co-ordinating Lead Author for the Fifth Assessment Report of the IPCC, and is the Editor of Environment and Development Economics, a Cambridge University Press journal.



Hua Wang Renmin University of China

Dr. Hua Wang is Professor of Environmental and Resource Economics and Dean of the School of Environment and Natural Resources at Renmin University of China (RUC). Dr. Wang holds a Ph.D. in Environmental Management and Policy from the University of North Carolina at Chapel Hill and worked before as Senior Environmental Economist at the World Bank's Development Research Group and Chief Expert in the Policy Research Center of China's Ministry of Environmental Protection (MEP). He conducted extensive research in the areas of economic valuation of nonmarket goods and services, policy instruments for industrial pollution control, global environmental governance, and institutional strategies for sustainable development and ecological civilization, in countries including China, United States, Philippines, Thailand, India, Armenia, Indonesia, Ghana and Ukraine. He published dozens of articles in journals including Journal of Environmental Economics and Management, Journal of Development Economics, Ecological Economics, Environmental and Resource Economics, and China Economic Review. Dr. Wang is currently Chairman of the Chinese Association of Environmental and Resource Economists (CAERE) and Honorary President of the Professional Association for China's Environment (PACE).

#### Instructions for Paper presenters

#### New paper file

If you wish to update your paper file we ask you to do this by May 28. To do this, follow these steps: (a) Sign in to your account at http://fleximeets.com/wcere2018/; (b) Click "View Submissions."; (c) Click on the paper you want to edit. (d) On the right, under "Edit submission", click "Upload file" to upload your new file, which will replace your earlier file. Note that if you choose not to upload a new file, your original file will remain.

#### **Author names**

Please check the order of the list of authors for your paper and, if necessary, re-order them so they correspond to the order on your title page. To change the order, repeat steps 1(a), 1(b) and 1(c) above. Then, under "Edit submission", click "Edit Authors". To change the order of the authors, click the symbol to the left of the author number and drag names to reorder them.

#### **Presentation format**

A computer (MS Windows environment) will be available in each room at the conference venue. Please bring your presentation on a USB disk, because connecting of personal laptops might not be possible. Your presentation should be in PowerPoint (.ppt or .pptx) or .pdf format, and should be named with your last name to avoid confusion. Each room is equipped with a laser presenter and a whiteboard (please use with whiteboard pens available in the room only).

#### **Organization of sessions**

Most sessions will be 1 hour and 45 minutes. The time available for regular papers is 25 minutes, distributed as follows: 15 minutes for presentation, 5 minutes for discussant's comments, and 5 minutes for general discussion. Presenters should come to the room 10 minutes prior to the start of the session so that presentations can be copied onto the computer before the session begins. A conference assistant will be available near each room in case of technical difficulties. Please go to the assigned room well in advance of when your session starts to show respect to your colleagues and the audience. #### **Presentation format**

A computer (MS Windows environment) will be available in each room at the conference venue. Please bring your presentation on a USB disk, because connecting of personal laptops might not be possible. Your presentation should be in PowerPoint (.ppt or .pptx) or .pdf format, and should be named with your last name to avoid confusion. Each room is equipped with a laser presenter and a whiteboard (please use with whiteboard pens available in the room only).

#### **Organization of sessions**

The egg-timer session will be 40 minutes. The time available for egg-timer papers is 10 minutes, distributed as follows: 7 minutes for presentation, and 3 minutes for general discussion. Presenters should come to the room 10 minutes prior to the start of the session so that presentations can be copied onto the computer before the session begins. A conference assistant will be available near each room in case of technical difficulties. - c. The fewer slides you have the better.
- d. Be prepared for your presentation to be cutshort if you go over time.

#### **AERE Fellows Award**

In 2005, the AERE Fellows program was instituted to recognize outstanding contributions to the advancement of the profession of environmental and resource economics. The prize is awarded in even years only if one or more awardees deserving the prize have been nominated.

# **European Practitioner Achievement Award in Applying Environmental Economics**

The Award recognizes Practitioners in the policy or business arena who have made signal contributions in the application of economic ideas.

Eligible candidates are those who work or do substantive business in Europe; have demonstrated courage and skill in successfully achieving the implementation of environmental economics ideas. The prize is awarded in even years only if one or more awardees deserving the prize have been nominated.

# **EAERE Award for Outstanding Publication in the Journal Environmental and Resource Economics**

The EAERE Award for Outstanding Publication in the Journal Environmental and Resource Economics (ERE), recognizes exemplary research published in ERE during the past year. Any article published in ERE during the preceding year is eligible for this award. The Award is given annually and announced at the EAERE Annual Conference. Thanks to the kind support of the Journal publisher, Springer, winners are awarded with Springer books vouchers to the value of EUR 550 and a cash amount of EUR 750, to be divided equally between co-authors.

# **European Achievement Award for Researchers in Environmental Economics under the Age of Forty**

The European Achievement Award for Researchers in Environmental Economics under the Age of Forty is a recognition given every year to the environmental economist under the age of forty who is judged to have made the most significant contribution to environmental economic thought and knowledge. If there is a significant body of joint work, the prize may be awarded jointly to two recipients provided that both recipients are under the age of forty. The Award is honorary and materially consists of Springer books vouchers to the value of EUR 1.000.

# **EAERE** Award for ERC Grants laureates in the field of environmental and resource economics

The "EAERE Award for ERC Grants laureates in the field of environmental and resource economics" intends to recognize the scientific excellence of ERC individual grantees (Starting Grants, Consolidator Grants and Advanced Grants). It aims at welcoming Awardees to the EAERE community by granting them a complimentary membership for the time of their ERC Grants. Awardees are offered to publish regularly outputs of their research projects via the EAERE magazine, communication channels and social networks, so that EAERE members will be constantly updated about the progresses of the results of frontier research in Europe.










#### **AERE AT A GLANCE**

The Association of Environmental and Resource Economists (AERE) is an international professional association for economists working on the environment and natural resources. Founded in 1979, AERE continues today with its mission: facilitating the exchange of ideas, stimulating research in environmental and resource economics, and promoting graduate training. AERE has over 1,000 members in more than thirty nations, at academic institutions, the public sector, and in private industry.



Over its history, AERE has sponsored several journals and now owns two: the *Journal* of the Association of Environmental and Resource Economists (JAERE) and the Review of Environmental Economics and Policy (REEP), which are published by the University of Chicago Press and Oxford University Press, respectively. Now in its fifth year, *JAERE*'s success as the new flagship research journal for AERE has resulted in its expansion from four to six issues per year beginning in 2019. AERE is also proud of REEP, its policy journal, which ranks in the top 15 of all economics journals in terms of impact factor, and is also highly rated among environmental science journals.

The association offers members a wide range of opportunities to present their research and to interact with professional economists. AERE has co-hosted the World Congress since its inception and hosts an annual Summer Conference each June (except in years when there is a World Congress).
